Agenda Item 1 - Minutes of the Last Meeting

1. The Minutes of the last meeting of the Council held on **02 June 2010** were read and agreed a true record.

Agenda Item 2 - Matters Arising

2. The letter of thanks to Highways for completing their contribution towards the Gembling drainage project has been sent.

3. The Clerk submitted the letter written to ERYC relating to Gembling Common as outlined in the last meeting (02 Jun Meeting Minutes paras 21-23), and the inadequate and confused response from Mr Goodison. The letter from the Clerk to Mr Goodison detailing the errors and asking for advice on a number of related issues was also passed around. Although the matters covered are complex, and resolution could be difficult, it was agreed that they should be dealt with due to the responsibility that the PC have for Commons. We will await the advice from ERYC.

4. The Clerk passed out these leaflets for display on notice boards and distribution.

5. Mrs Foreman outlined the detail of a brief meeting that included the following:

6. Pitched roof and stack Elm Tree farm Brigham DC/10/02289/PLF/EASTNN was discussed. There had been contact between Councillors and the applicant. There were no issues, and the application was agreed.

7. Single storey extension Fallowfield House, Foston, 10/01647/PLF/EASTNN/PS has been granted by ERYC.

8. An application for funding to service the St Andrew's Church clock Foston on the Wolds (£189:18p) had been received and was discussed. It was unanimously agreed to make the grant.

9. Audit Commission/Invoice for £158:63p had been received and the cheque was signed for payment.

10. The Clerk outlined the Bank Charges set against the PC account and the matching rebate that followed.

11. Mr Hostick mentioned that the evidence of recent events indicated that perhaps Gembling School had not appreciated the assistance the PC could offer. It was asked that Mr Tate take a clear message to the Head that funds were available if application was made, and this he agreed to do.

12. Mr Tate said that the last assembly was 23 Jul 2010. It was agreed that the cheque for prizegiving (\pounds 75) would be passed to Mr Watts who kindly agreed to present it. The agreed amount, for reference from PC Meeting Jan 2010, was:

4. Gembling School Prize: Mr Tate briefed the Council on his discussion with the Head. It was proposed that:

- a. Book tokens to the value of £15 are the preferred option.
- b. There would be 5 prizes for the different age groups.
- c. The total value would be £75 for the Council per annum.
- d. It was confirmed that the shield is awarded to the student showing many qualities, not necessarily academic or sport. This was welcomed by the Council.
