- d. Community Emergency Plan – **Agreed** that Councillors Fleming and O'Connor would meet in order to update the Plan prior to the next meeting.
- e. Public Right of Way – Foston Public Footpath No.1. ERYC Countryside Access Officer, Sam McGivern has confirmed that the temporary closure order was extended in July and that the footpath will remain closed until January 2020. The Environment Agency had agreed to some improvement options to either the bridge or the adjacent bunding to provide a safe temporary alternative route for the footpath but these works have not yet been completed. Sam McGivern has contacted the EA and will continue to monitor the situation and will update the Parish Council when she has any further information.
- f. Parish Council Cluster – **Agreed** that Councillors Mrs Foreman, Fleming, Watts and O'Connor

would attend the meeting being held in Foston Village Hall on 10<sup>th</sup> October 2019 at 6.30pm.
